

Pennsylvania PTA 2020 Convention Workshop Presenter Request for Proposal

On October 23-24, 2020, we will gather in Grantville, PA at the Holiday Inn Harrisburg Hershey, 604 Station Road for our 111th Annual Convention. Members from PTAs across the state will convene to help decide the future of PTA in the shaping of the new bylaws and engaging in learning and training opportunities.

We are accepting proposals for workshop presentations on October 23 and 24, 2020 and would appreciate the expertise and knowledge you could share with convention attendees. The workshops should have a focus on strengthening partnerships, promoting child advocacy issues, or training for our PTA leaders. To help you while considering your presentation topic, some points to keep in mind:

- Audio-visual needs – we will provide an LCD projector upon request
- As a presenter, you are welcome to spend the day with us and attend other workshops and general meetings as our guest.

In addition, workshops must be educational in nature and they should reflect the Mission Statement of the PTA (see below). Our budget does not allow for reimbursement for presenters and presentations are provided gratis.

If you are interested in presenting a workshop, please submit the attached proposal form by June 29, 2019. You are welcome to include additional materials, brochures, etc. to further describe your presentation to supplement the brief description on the form.
